The creation of the Yugoslav and Rwanda Tribunals, spurred on by actions of the United States government, involved making fundamental choices concerning the Tribunals' authority, method of creation, basic structures and procedures, and jurisdiction. These tribunals revived international prosecution as a means of providing justice in the wake of atrocities, managing conflicts, and deterring future crimes.

The international criminal tribunals for Yugoslavia and Rwanda reshaped international criminal law. Even before the formal end to the International Criminal Tribunal for Rwanda's operations, there was much talk about its legacy. This article demonstrates a sharp contrast between the ambiguities of what is and can be known about the Tribunal's legacy. Building on social theorist Zygmunt Bauman's work on "bids for immortality," it identifies the phenomenon of "legacy talk," that is, attempts to consolidate a set of interpretations about the substance and value of what remains prior to the departure of the legator.

The Impact of the ICTY on the Former Yugoslavia: An Anticipatory Postmortem *Marko Milanović* 233

As a series of public opinion surveys indicate, the International Criminal Tribunal for the Former Yugoslavia seems not to have persuaded populations in the various successor countries that the findings in its judgments are true. These surveys highlight strong relationships between the respondents' ethnicity, their perception of the ICTY's bias against their group, and their distrust of the ICTY and of its findings.
